Richard J. Donovan Correctional Facility (RJDCF) is a forensic correctional facility that houses approximately 3,000 minimum to maximum security level male inmates. It accommodates inmates with severe mental illness, high risk medical issues, LGTBQIA status, and issues associated with substance use.

Administrative Segregation Unit Clinician Duties (August 2020 to November 2023):

- Work with a caseload of patients admitted to the Administrative Segregation Unit (ASU) with a variety of mental illnesses and custody classifications to provide individual therapy and group therapy
- Complete weekly suicide risk assessments, initial psychosocial assessments, and treatment planning including diagnosing and assessing chronic and acute risk factors
- Make patient case presentations during weekly treatment team meetings with interdisciplinary staff
- Assess inmates to determine whether placement in the Mental Health Services Delivery System (MHSDS) is appropriate based on mental health needs
- Provide crisis intervention services to patients expressing suicidal and/or homicidal ideation as well as signs of grave disability
- Work alongside an interdisciplinary treatment team including psychiatry, custody, and medical staff to ensure appropriate treatment for patients in treatment planning
- Fill in as needed for lead clinical duties including triaging, leading treatment team meetings, managing a treatment team of six to seven clinicians, organizing staff coverage, and other administrative duties such as reporting on patient movement and collaborating with custody to solve issues as they arise

Mental Health Crisis Bed Duties (October 2022 to November 2023):

- Fill in for crisis bed staff as needed conducting daily mental health rounds with patients housed in the Mental Health Crisis Bed (MHCB) while assessing for continued risk of harm to self and others as well as grave disability
- Provide therapy and crisis interventions to inmates admitted to the Inpatient Hospital/ Outpatient Housing Unit/Mental Health Crisis Beds
- Complete psychosocial intake assessments and suicide risk evaluations for newly admitted patients

- Training alongside a licensed psychologist who conducts forensic evaluations such as offenders with mental disorders (OMD), competency to stand trial, sexually violent predator, franklin, and mental health diversion evaluations

- Receive structured guidance from supervisor on how to formulate reports and answer referral questions pertaining to criteria such as for release on parole, competency to stand trial, violence risk, diagnostic clarity, and general risk for criminal and sexual recidivism

## **Orange County Health Care Agency Juvenile Recovery Court (JRC) & Youth Guidance Center (YGC), Orange, CA**

Juvenile Recovery Court is a collaborative program between Children and Youth Behavioral Health Services, probation, and the juvenile court for youth who have committed substance related offenses. Youth Guidance Center is an 80-bed facility providing custody accommodations for youth in order to meet commitment needs of the Juvenile Court. YGC offers two programs aimed at drug and alcohol users with the goal of providing CBT interventions to encourage pro-social thinking and emotional, behavioral, and vocational development.

- Provided weekly individual therapy and case management to a small, diverse caseload of youth, both in custody (Juvenile Hall, probation camps) and outpatient, in the JRC program as well as ran men's process group once a week and conducted psychological testing when necessary
- Completed documentation for Medi-Cal billing on a weekly basis
- Consulted with a diverse population of families of youth in JRC program including low income, LGBTQ, gang affiliated, language barriers, and immigration status issues in order to provide families information and support regarding their youths in the program
- Collaborated and consulted with staff and outside community resources including probation staff, rehabilitation facilities, and wraparound services to connect youths with services that will assist them during and after completing the JRC program
- Once per week a multidisciplinary team including mental health clinicians, probation staff, attorneys, the DA, and the judge meet to discuss all JRC cases followed by attending court where the judge sees each youth to go over progress, violations, and other matters. Practicum students are involved in this

process and interact with the court on a weekly basis to provide support for youth and updates on youth progress in treatment

- Provided weekly individual therapy and case management to a small caseload of youth in custody prior to shifting to JRC program
- Ran a weekly Seeking Safety group and conducted psychological testing when requested by clinicians and YGC probation staff

### **View Heights Convalescent Hospital, Los Angeles, CA**

View Heights Convalescent Hospital is a locked inpatient psychiatric facility for the severely mentally ill who are under conservatorship per the state of California and have been diagnosed with disorders on the psychotic spectrum. Residents are provided with mental health and medical services in an effort to increase stability and independence to discharge to a lower level of care.

- Worked part-time running mental health and substance abuse-based groups on both the acute and stabilization units of the facility (three to four groups per week)
- Conducted one-on-one intake interviews with residents in order to gather history and gauge current symptoms
- Provided full battery assessments for residents in need of testing including assessments/inventories such as PAI, MCMI, MMPI, Rorschach, WAIS, RBANS, TAT, BDI, and BAI
- Integrated and interpreted assessment results, background information, and chart information into confidential psychological evaluations for individual residents
- Developed a substance abuse and relapse prevention curriculum as well as medication compliance curriculum for weekly psychoeducational groups
- Provided milieu therapy when available to offer support to residents before and after groups as well as throughout the day
- Assisted supervisor with research and presentations
